Impact from arrows – flying or from misuse of equipment Injury to people, damage to environment, buildings or equipment	Everyone on the range Spectators Anyone stood or walking nearby	Set up of the range complies with Archery GB safety specifications – included in equipment box. All instructors must hold a TSA Archery Permit, which includes assessment on the safe use of equipment and how safely and effectively demonstrate this to users. Bows and arrows matched carefully to a user's draw length and strength. Boundaries of the range clearly marked. The activity is to be halted immediately if any person or animal strays into the vicinity of the range, using the agreed signal, communicated to users and instructors at the start of their session. Participants to shoot from the designated shooting line and only once they are told it is safe to do so by an instructor. Bows to kept on the shooting line once assembled. Bows and arrows to be kept always pointing down the range and never towards another person. Arrows are counted at the start and end of each session to ensure all are accounted for. Range constructed of materials to reduce bounce back of arrows – foam targets rather that straw, back drop netting to take impact of arrows. Closed toe shoes must be worn. Loose items, such as neckers removed before shooting and long hair tied back. Any suspected dangerous behaviour to be controlled immediately.
